5. Job Description :
  - Research digital spatial data, especially real-oriented space and geospatial information description in Game engine, and control.
  - Telecommunication engineering. In the view of game engine, research comparison, verification and systemization of other spatial data description (BIM, point cloud, GIS, etc.).
  - Research sensing, processing and telecommunication of various agents' coordinates, orientations and poses.
  - Managing various collaborative and commissioned research mentioned above.
6. Eligibility : Practical experience about one of the study contents mentioned above or the plural number. Candidate must have Master degree.
7. Contract Term : As early as possible after April 1, 2023
  - ※The first-year contract will be ended on March 31, 2024. The contract is renewable on a fiscal year basis (from April 1 to March 31; every year) according to the following relevant factors, such as budget status, progress of the work assigned, the amount of the work at the end of the term, applicant' s performance, work record, and attitude, and applicant' s medical conditions.
  - ※Probationary period is 6 months from the date of arrival.
8. Wages and Compensations:

To be determined in accordance with The University of Tokyo Regulations. A monthly payment of JPY200,000 or more, based on experience, achievements, etc., not exceeding JPY600,000 per month. (Including achievement allowance.)

Commuting allowance is JPY55,000 per month at maximum. There is no pay raise system within the contract period
